**INTRODUCTION AND AMENDMENT REGISTER  
BRIMFIELD TOWNSHIP ZONING RESOLUTION  
PORTAGE COUNTY, OHIO**

The Board of Trustees of Brimfield Township, Portage County, Ohio deemed it was advisable to promote the public health, safety, and morals for the residents of the township by zoning the building and land use of the unincorporated territory of the Township.

The Township in accordance with Chapter 519 of the Ohio Revised Code adopted a Zoning Resolution. In accordance with Ohio Revised Code Section 519.04, the Board of Trustees has appointed five (5) residents to serve as a Zoning Commission.

The Zoning Commission has recommended certain amendments to the Township Zoning Resolution and having submitted them to the Board of Trustees.
